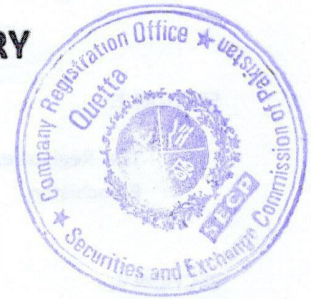

**Memorandum and Article of Association of
Chamber of Commerce & Industry Quetta (Balochistan)**

SECTION 1.

The name of the association is CHAMBER OF COMMERCE & INDUSTRY QUETTA (BALOCHISTAN).

SECTION 1(a)

The jurisdiction of the Chamber shall extend to whole of the District of Quetta It has a minimum of 150 members who are either permanently domiciled in Quetta District or have a substantial business interest such as an industrial concern, a corporate business entity or being assessed for the purposes of income tax and sales tax in territorial jurisdiction of Chamber of Commerce & Industry Quetta.

SECTION 2.

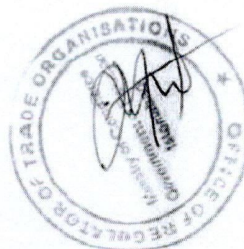
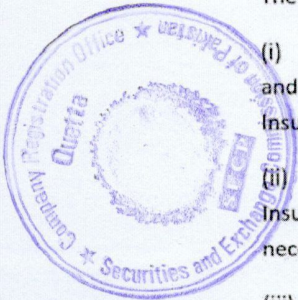
The Registered Head Office of the Chamber shall be situated at Quetta in the Province of Balochistan.

OBJECTS

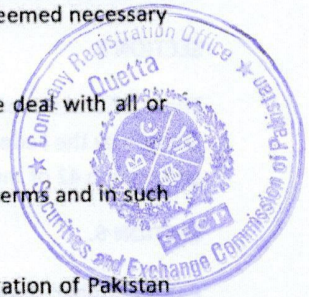
SECTION 3.

The objects for which the Chamber is established are:-

- (i) To Promote, develop, stimulate and protect the economic interest of Pakistan in general and of those engaged in Industry, Trade, Commerce, Minerals, Transport, Agriculture, Banking, Insurance and Shipping in particular.
- (ii) To consider all questions connected with Trade, Industry, Minerals, Transport, Banking, Insurance, Agriculture, Manufacture, Shipping and Commerce and to initiate and or support necessary action connected therewith.
- (iii) To consider support or oppose legislative or other Governmental measures affecting the economic interest of businessmen & industrialists and also make representations to Government or grievances if any, concerning with the Central Government of Pakistan and the Provincial Government of Balochistan or any local body or authority.
- (iv) To adjust controversies between members of the Chamber.



- (v) To collect and circulate statistics and other information relating to the Commercial, Industrial Agricultural and financial interests of the businessmen and industrialists.
- (vi) To arbitrate in settlement of disputes arising out of commercial transaction between parties willing or agreeing to abide by the judgment and decision of the Chamber.
- (vii) To form a code of practice and facilitate transaction of business to frame bye laws for the Office Bearers and rule and regulations for the staff of the Chamber to carry out various objects of the Chamber.
- (viii) To communicate with the Chambers of Commerce and mercantile or public bodies inside or outside Pakistan and to concert and promote measures for protection of trade, commerce, industry and agriculture.
- (ix) To purchase and construct, take on lease or in exchange, hire or otherwise acquire land and buildings and all other property, moveable or immovable, which may be deemed necessary for the purpose of the Chamber.
- (x) To sell, improve, manage, develop, mortgage, dispose of or otherwise deal with all or any part of the property of the Chamber.
- (xi) To borrow or raise money for the purpose of the Chamber upon such terms and in such manner as the chamber may think fit.
- (xii) To subscribe to and become a member of, and co-operate with Federation of Pakistan Chambers of Commerce and Industry and procure from and communicate with any Chamber and Association of trade and industry such information as may be likely to forward the cause of the Chamber.
- (xiii) To accept bequest donations or subscriptions towards or to accumulate and provide fund or endowment or wakf and to invest the same and apply the income arising there from or resort to the capital thereof, for any objects of the Chamber.
- (xiv) To aid and to receive aid from other Society, Association, Company, Corporation, Firm, Partnership or Person or formed or intended to promote any to the object of the Chamber, Corporation, Firm, Partnership or Person with a view to obtaining any advantage or Society as may be considered from time to time.
- (XV) To subscribe to any local or other charities and to grant donations for any Public purposes and to provide provident or superannuation funds for the servants of the Chamber or otherwise to assist any such servants their widows and children.
- (xvi) To draw, accept, endorse cheques, bills, hundies, notes or other negotiable instruments and to invest or operate in accounts of the Chamber with any Bank or Bankers.
- (xvii) To establish a commercial and statistical Library and a web site.



(xviii) To remunerate any person or company for services rendered or to do rendered in placing or assisting to place or guaranteeing to place any debentures or other securities of the Chamber.

(xix) And generally to do all that may be necessary to attain the above objects of the Chamber directly or indirectly and to do all such other things as may be conducive to the development of trade, commerce, industry, agriculture minerals, transport, shipping, banking and insurance among the businessmen and industrialists in Pakistan.

SECTION 4.

The income and property of the Chamber, whensoever derived shall be applied solely towards the promotion of the objects of the Chamber as set forth in Memorandum and Article of Association and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise, however, by way of profit to the members of the Chamber provided that nothing herein shall prevent the payment in good faith of remuneration to any member of the Chamber or any other person in return for any service actually rendered for the Chamber.

SECTION 5.

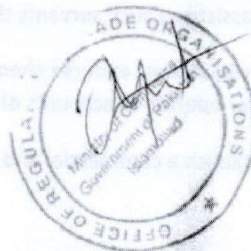
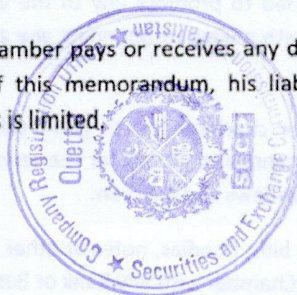
The 4th 5th and 9th paragraph of Trade Organizations Rules 2013 are conditions on which a license is granted by the Federal Government to the Chambers in promulgation of trade organizations Act 2013 and section 42 of the Companies Act 2017.

SECTION 6.

Every member, trade, group and town association affiliated with the Chamber undertakes to contribute to the assets of the Chamber in the event of the same being wound up during the time that he is a member or within one year afterwards, for the payments of the debts and liabilities of the Chamber contracted before time at which he ceases to be a member and of the costs, charges and expenses of winding up the same and for adjustment of the rights of contributories amongst themselves such amounts as may be required not exceeding the sum due upto the date of such winding up on account of subscription which is fixed at rupees fifty per annum in case of each member, trade group, and town association.

SECTION 7.

If any member of the Chamber pays or receives any dividend bonus or other profit in contravention of the fourth paragraph of this memorandum, his liabilities shall be unlimited. Except as above the liabilities of the members is limited.



SECTION 8.

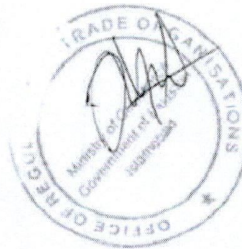
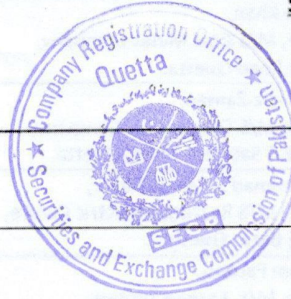
If upon winding up or dis-solution of the Chamber, there remains after the satisfaction of all its debts and liabilities, any property whatsoever the same shall not be paid to distributed amongst the members of the Chamber but shall be given or transferred to some other institution or institutions having objects similar to the objects of the Chamber and which shall prohibit the distribution of its or their income and profit among its or their members to an extent at least as great as is imposed on the Chamber under or by virtue of clause IV thereof. Such institution or institutions to be determined by the majority of the members of the Chamber at or before the time of dis-solution or in default thereof by such Judge of the Court in Quetta as may have or acquire jurisdiction in the matter.

SECTION 9.

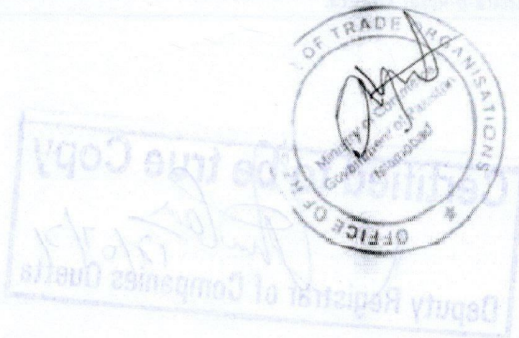
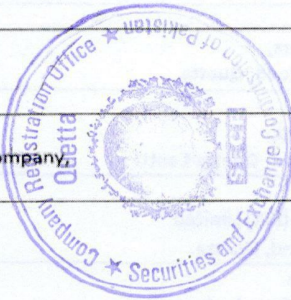

ARTICLES OF ASSOCIATION

OF

CHAMBER OF COMMERCE AND INDUSTRY QUETTA-BALUCHISTAN
CONSTITUTION OF THE CHAMBER



ARTICLE 1

The Chamber of Commerce and Industry Quetta is established with the limited liability of members but if any member of the Chamber pays or receives any dividend, bonus or other profit, in contravention of fourth paragraph of the Memorandum of the Chamber, his liability shall be unlimited in accordance with and subject to the provisions of the Companies Act 2017 and trade Organizations Act 2013.

ARTICLE 2

The regulation for the management of the Chamber and for observance of the members thereof and their representatives shall, subject to exercise of the statutory powers of the Chamber in reference to the repeal or alteration or addition to its regulation by special resolution as prescribed by the said Companies Act 2017 be such as are contained in these Articles.

INTERPRETATIONS

ARTICLE 3

- (a) "Chamber" means a Chamber of Commerce & Industry Quetta-Balochistan organized to represent trade, industry and services in Quetta District, incorporated and registered under the provision of section 42 of the Companies Act 2017.
- (b) "Member" means a registered member of the Chamber.
- (c) "'Corporate Member" means a member of a Chamber which is either a body corporate or a multinational corporation with his head office or branch office in Pakistan or a sales tax registered manufacturing concern or a sales tax registered business concern having annual turn-over of Rs. 50 million or above.
- (d) "Associate member" means a Member of Chamber which is not a body corporate or a multinational or a sales tax registered manufacturing concern or a sales tax registered business concern having annual turn-over of Rs. 50 million or above.



- (e) "**Federation**" means a Federation of Pakistan Chambers of Commerce & Industry organized on All Pakistan basis to represent Chambers, Associations, Women's Chamber and Chamber of Small Traders.
- (f) "**General Body**" mean all member of Chamber of Commerce & Industry Quetta.
- (g) "**Act**" means the Trade Organizations Act 2013.
- (h) "**Secretary General**" means an individual professional full time employee of Chamber of Commerce & Industry Quetta, who shall be in-Charge of the Secretariat of the Chamber and Responsible for day to day operations of the Chamber and in his capacity as such shall be the Custodian of all record pertaining to the Chamber.
- (i) "**Town Association**" means a Town Association organized to the represent Trade, Industry or Service in a Town, Tehsil, Taluka or a District where there is no Chamber and such Town Association shall be affiliated with the Chamber of the concern district.
- (j) "**Women Entrepreneur**" means a Sole Proprietorship or a Partnership where the Proprietor or the majority partners are female.
- (k) "**Office Bearer**" means and includes the President, Senior Vice President and Vice President and the Members of the Executive Committee.
- (l) "**Committee**" means the Executive Committee of the Chamber.
- (m) "**Committee Meeting**" means the meeting of the members of the Executive Committee duly Called and constituted.
- (n) "**Office**" means the registered Head Office of the Chamber.
- (o) "**Service Rules**" means the service rules framed and approved by the Executive Committee of the Chamber governing the terms and conditions of service etc, of the paid employee of the Chamber.
- (p) "**Regulator**" means Director General Trade Organizations

ARTICLE 4

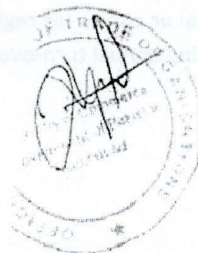
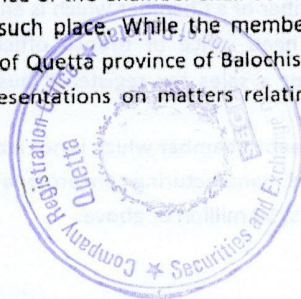
For the purpose of registration the Chamber is declared to consist of not less than 150 members.

ARTICLE 5.

The Chamber is established for the purpose expressed in the Memorandum of Article of Association of the Chamber.

ARTICLE 6.

The registered Head Office of the Chamber shall be at Quetta and the business of the Chamber shall be carried on at such place. While the membership of the Chamber shall normally be confined to the district of Quetta province of Balochistan, the Chamber shall be free to express opinions or make representations on matters relating to all Pakistan Trade, Commerce and Industry.



CLASSES OF MEMBERS

ARTICLE 7.

There shall be four classes of Members namely:-

- (a) Corporate Members
- (b) Associate Members
- (c) Women Entrepreneurs
- (d) Town Associations

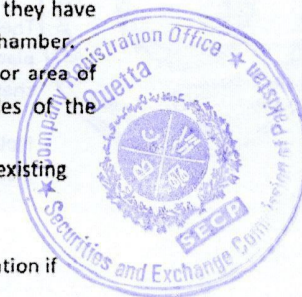
MEMBERSHIP

ARTICLE 8

1) Any partnership firm Joint Stock Company. Corporation or Association engaged in trade, commerce, manufacturing industry, transport banking, insurance, accountancy, shipping, agriculture or mining shall be eligible to become a member in their conventional or corporate name provided they have their business Head Office, situated in the areas falling within the jurisdiction of this Chamber.

Any business concern shall be eligible for grant or renewal of membership of Chamber if such business concern meets the following conditions:-

- (a) The prospective member is a joint stock company, corporate body, sole proprietorship or a partnership firm or an Association of persons or a company holding National Tax Number and Sales Tax Registration, if applicable, in the name of the business concern engaged in trade, commerce, agriculture, manufacturing industry, shipping transport, mining, accountancy, banking shall be eligible to become members provided they have their business Head Office, situated in the area within the jurisdiction of this Chamber.
 - (b) The prospective members business fits with in the defined business Scope or area of jurisdiction of the chamber as provided in the Memorandum and Articles of the Association of the chamber.
 - (c) The application for grant of membership has been proposed and seconded by existing members of the chamber.
 - (d) The prospective member has no criminal conviction and
 - (e) The prospective member has a valid National Tax Number and sale Tax Registration if applicable.
- (2) There shall be two classes of membership in the chamber:
- (a) A member which is either a body corporate of a multinational corporation with its head office or branch office in Pakistan or sales tax registered business concern having annual



- turnover of Rs. 50 million or above shall be called Corporate Member and
- (b) A member which is not a body corporate or multinational or a sales tax registered manufacturing concern or a sales tax registered business concern having annual turnover of Rs 50 million or above shall be called Associate Member.
 - (3) Membership may be cancelled or such membership be disqualified, in addition to the grounds provided under the chambers Memorandum and Articles of Association, if the member breaches any provision of these rules or the Ordinance.
 - (4) The membership of the chamber shall be granted for a period of one year and shall expire on The 31st day of March every year irrespective of the date of grant of membership,
 - (5) The membership shall be renewable on annual basis subject to the following conditions namely:-
 - (a) Payment of prescribed subscription within the time stipulated in the Memorandum which shall not be later than 31st of March.
 - (b) Proof of filing return of income tax and sales tax, if applicable, for the preceding year.
 - (6) The Regulator Trade Organizations, if satisfied that the renewal of membership of an eligible member has been delayed or refused, upon a complaint filed by the aggrieved member, may direct the Chamber of Commerce to renew the membership of the applicant.

Note- As specified in Article 8, above, no firm / individual registered with the Government is entitled to become a Member of the Chamber. (Ministry of Commerce, Government of Pakistan clarification No. 7(12)783.T.O. dated 17-6-1986).

TOWN ASSOCIATIONS

ARTICLE 09

These will comprise the following:-

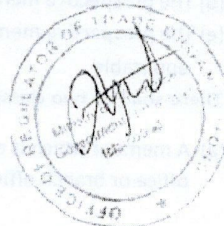
Town Association means a Town Association, organized to represent trade, industry, or service in a Town, Tehsil, Taluka or a District where there is no chamber and such Town Association shall be affiliated with the chamber of the concerned District.

WOMEN ENTREPRENEUR

ARTICLE 10

These will be individuals / firms organized to represent Trade and Industries on local basis or at places falling within the jurisdiction of the Chamber where the proprietor / partners or majority shares are held by females.

Note: - Commercial and industrial Concerns in area covered by Town Association can also become direct Members of the Chamber.



ANNUAL SUBSCRIPTION

ARTICLE 11:- Any candidate for membership shall have to pay Membership fee and annual subscription according to the scale duly approved by the Executive committee of Chamber of Commerce and Industry Quetta-Balochistan through resolution by two third majority. Any fee scale fix by the Executive Committee would be final whatever and whenever resolved. The fee scale is:

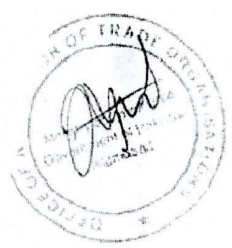
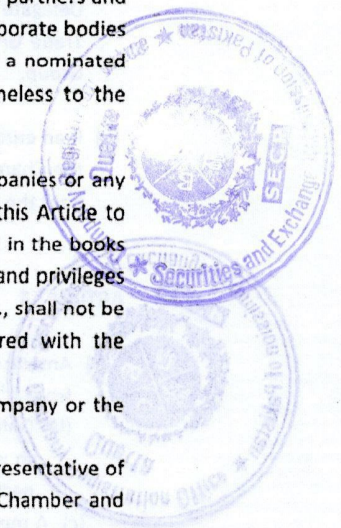

REPRESENTATION IN THE CHAMBER

ARTICLE 12:

Subject to the provision & restrictions in these Articles or any rules made their under and verification of the representative of respective class by the Chamber, the rights and privileges of membership representation may, in the case of partnership and individual firm registered in the conventional name as members of the Chamber, be exercised by legally registered partners and proprietors of such firms and in the case of joint stock company or other such corporate bodies registered in their corporate name as members of the Chamber be exercised by a nominated Director or Chief Executive of the company or corporate body subject nevertheless to the following reservations namely:-

- i. The partners and proprietors of firms and Directors and Chief Executives of Companies or any other corporate body not below the rank of General Manager is entitled under this Article to exercise the rights and privilege of membership must have their names registered in the books of the Chamber in the prescribed manner in order to Exercise the aforesaid rights and privileges provided that a person having representation in different firms and companies etc., shall not be eligible to represent in more than two such firms / corporate bodies registered with the Chamber.
- ii. For such act of exercise of the rights and privileges of membership by a firm, company or the corporation members, only one representative shall be recognized.
- iii. Unless otherwise determined by the Executive Committee only one registered representative of firm, company or corporation members shall be entitled to attend a meeting of Chamber and take part therein.
- iv. A member may replace his representative at any time during the year for the purpose of Article 35 but if he is already represented on the Executive Committee or any Sub-Committee he shall continue to serve on it until the new Executive Committee is elected or the Sub- Committee is reconstituted, subject to Article 18, provided that such a representative shall have the right to resign from the Executive Committee or Sub Committee at any time.



Note:- In case no change in the name of the representative is intimated to the Chamber upto 31st March, then the representatives already registered with the Chamber will continue to represent the members for the purpose of Article 35

APPLICATION FOR MEMBERSHIP

ARTICLE 13

(a) Every application for membership shall be made in the form in appendix 'A' accompanied by the Admission Fee, Subscription Fee for the first year, proof of the exact location of the business premises, Photostat copy of the identity card of the representative appointed and NTN registration number and proof of filling of return of income or statement U/S 143 B under the income tax Ordinance, 1979 for the latest preceding assessment year as and when the applicant is borne on the income tax register be presented to the Secretary of the Chamber, who shall on receipt of the same, place such application on Agenda for the next meeting of the committee, which shall thereupon consider such an application and accept or reject the same, in case of acceptance the date of the submission of the application will be considered as the date of enrollment as member of the Chamber for all purposes. If two-third members of the total members of the Committee vote against the admission of such application the application shall be deemed to be rejected with reason assigned thereto. The Secretary shall there-upon communicate the decision of the Committee to the applicant and in case the application is rejected the Secretary shall also refund the money paid with the application. Provided that application for enrolment as the Delegate Member, shall be forwarded to the Chamber through the applicant's Town Association/ Trade Group duly certified that the applicant is borne on the membership of such Association / Group.

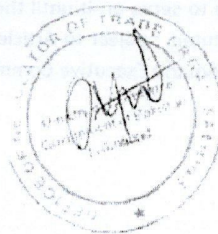
(b) If an enrolled Member of any Class of membership is removed from the register of Membership of the Chamber by or under any authority then such removed Member shall not be entitled to claim back the refund of the admission and subscription fee already paid to the Chamber.

ARREAR SUBSCRIPTION AND FORFEITURE OF DEFAULTER MEMBERS.

(a) Annual subscription paid in any month of financial year shall be counted for the year commencing from 1st April, which is the official year of the Chamber.

(b) Only such members as have completed two year on the rolls of the Chamber shall be entitled to vote or stand for election or nominate a candidate for election or send representations to participate in the elections.

(c) A member shall cease to be a member if he fails to pay his annual membership subscription up to 31st March in each official year of the Chamber through information conveyed to members through advertisement in one of the local Urdu News Paper.



LIABILITY TO PAY DUES AFTER CEASING TO BE A MEMBER

ARTICLE 15

Any member who by any means, ceases to be a member shall nevertheless remain liable for renewal of his membership on payment of fee as a new membership.

AFFILIATION

ARTICLE 16

- (a) Any Town Association, whose objects are similar to those of the Chamber, may be affiliated to the Chamber as per Trade Organizations Act 2013 upon such terms and conditions as the Committee may deem fit.
- (b) The Chamber shall not secure affiliation with any international or foreign body except with Federation.

CESSATION OF MEMBERSHIP

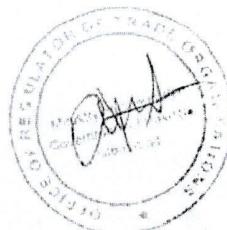
ARTICLE 17

Any member or members shall cease to be member(s) of the Chamber:-

- (a) On his or their being adjudicated insolvent or in the case of the company or corporation, when winding up orders have been passed with regard to such company or corporation or when it has gone into voluntary winding up except for the purpose of reconstitution;
- (b) On the termination of membership under Article 14(c);
- (c) In the case of a firm, Joint Stock Company or other corporation upon any change being made in the name of the company or corporation;
- (d) On his or their ceasing to be qualified or eligible for membership in terms of these Articles;
- (e) In the case of an individual when he has been proved to be of unsound mind or has been punished with imprisonment of three months or more for an offence involving moral turpitude;

ARTICLE 18

When an individual firm company or corporation has ceased to be a member of the Chamber, such individual or representative of such company or Corporation shall automatically cease to be a member of the Executive Committee, if he was so elected, and also ceases to serve as representative of the Chamber on any public bodies.



PRIVILEGES OF MEMBER

ARTICLE 19

Subject to the restrictions contained in the provisions of these Articles generally or any bye-laws framed there under, any member shall, among other, have following rights and privileges:-

- (a) To obtain a copy of the annual report and accounts :
- (b) To obtain all other publications of the Chamber either free of cost or at such reduced rates as the Executive Committee may from time to time decide.
- (c) To have the free use of the Library of the Chamber :
- (d) To be present and discuss and vote at any General Meeting of any question referred to the General Body of members by circular or otherwise:
- (e) To nominate other qualified members for election or to be elected to the Executive Committee or other Committee or Committees; to join any deputation on behalf of the Chamber, or be elected to any office of the Chamber;
- (f) To stand for election as representative of the Chamber to any public or private bodies:
- (g) To seek the help of the Chamber in obtaining statistical or other information for the protection and advancement of business and to receive such particulars as may be available to the Chamber in regard to trade inquiries or information regarding Governmental or other measures affecting the trade;
- (h) To apply for the assistance of the Chamber for securing to him all reasonable facilities for the carrying on of the business and for the redress of all reasonable grievances,
- (i) To see the Minutes Book of the Executive Committee Meeting for which he shall have to give notice of 24 hours to the Secretary and seek his permission or he shall have to obtain the permission of the President in writing.

Note:-

(1) The Town Associations shall be treated as single entities each for the purpose of service and advice of the Chamber, but they shall receive five copies of the Chamber's Circular, publications, etc.



- (2) For the purpose of certification of the documents of the members of Town Associations, the rate of fee charged by the Chamber shall be not more than double than the rates fixed for the members.
- (3) For the purpose of certification of the status of the members of Town Associations, the Chamber shall make it clear that they are members of the Town Association / Women Entrepreneur affiliated to the Chamber & not members of the Chamber direct.
- (4) The Town Associations shall normally correspond with the Federal and Provincial Government through the Chamber to which they are affiliated.

RESIGNATION

ARTICLE 20

Any Member may withdraw from the Chamber by giving one month notice in writing to the Secretary General of his intention to do so and upon expiration of the notice such members shall cease to be a member of the Chamber subject to Article No. 15.

DISTINGUISHED PERSONS

ARTICLE 21

The Executive Committee may invite any person being a Government official connected with trade, commerce or industries or person distinguished in public service at a meeting of the Chamber or of the Executive Committee as they may think fit from time to time.

ADMINISTRATION

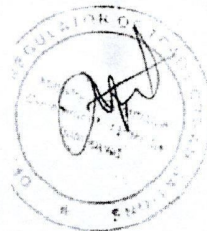
ARTICLE 22

The administration of the affairs of the Chamber shall be vested in a body called the Executive Committee herein referred to as the Committee.

COMPOSITION OF THE EXECUTIVE COMMITTEE

ARTICLE 23

The Chamber shall have representatives of various classes of members on its Executive Committee as follows:

Note: - There shall not be more than one representative on the Executive Committee for each Town Association and Women Entrepreneur, if the number of Town Association and Women Entrepreneur in the area covered by the Chamber is less than two each, their representation, and the total number of seats of the Executive Committee shall stand reduced proportionately.

ORGANIZATIONS STRUCTURE OF THE CHAMBER AND TERMS OF OFFICE

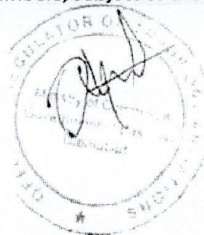
ARTICLE 24

- (1) The Chamber shall have a President, Senior Vice President and a Vice President who shall be elected from within the total strength of the Committee.
- (2) Each Class of members shall be entitled to elect only such number of representatives as is fixed for it on the Executive Committee.

Except as provided for in the case of Corporate and Associate Members, Town Associations, and Women Members, no members shall be eligible to participate in the election as a candidate other than one belonging to his own class of membership.

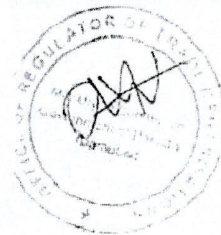
All members of a Trade Organizations shall constitute its General Body.

- (5) The General Body constituted under sub rule (3) in addition to the functions and responsibilities assigned to it in the Memorandum and Articles of the Association of Chamber of Commerce & Industry Quetta shall, subject to the provision of clause (c) sub rule (5) and sub section (7) of section 10 of the Ordinance serve as the electoral college for election of members of Executive Committee except for the seats reserved for women for which the electoral college shall be the Executive Committee.
- (6) The Executive Committee of Chamber of Commerce & industry Quetta shall comprise Persons elected by the General Body from amongst its members, subject to the



following, namely

- (a) There shall be maximum of 30 seats of Executive Committee
 - (b) At least 50% of the members of Executive Committee shall be from the Corporate Class.
 - (c) The Electoral College for each class of members of Executive Committee shall be the members of General Body from the respective class.
 - (d) In addition to the seats provided in clause (a), the immediate past president shall be an ex officio member of the Executive Committee without voting right.
- (7) In case of a Chamber, in addition to the number of seats in sub rule (5) there shall be two seats of Executive Committee reserved for Women Entrepreneurs, for which the electoral college shall be the Executive Committee
- (8) In case of a Chamber in addition to the seats in Sub Rules (6 & 7) there shall be two seats reserved for nominee of Town Association affiliated with the Chamber and approved by the Federal Government.
- (9) If any seat reserved for any of the member categories remains vacant, it shall not be filled with members from other category.
- (10) In a trade organizations where the General Body comprises at least 50% members from associate class, there shall be rotation of office of the president between the associate and corporate members.
- (11) Where there is a rotation of office of president under sub rules (10) the president and vice president shall not be from the same class of members. Provided that where there are more than one vice presidents or as the case may be at least one shall be from the class of members other than that of the president.
- (12) the office bearers of the chamber shall be elected by the Executive Committee from amongst its members.
- (13) The tenure of all elected office bearers shall be one year.
- (14) The tenure of members of executive committee shall be two years subject to the following:
 - (a) 50% members of the executive committee shall retire every year.
 - (b) After the election of the executive committee under the Ordinance, if applicable, a draw shall be made to determine the 50% members who shall retire after expiry of 1" year.
- (15) The tenure of office bearer of executive committee shall be one year.
- (16) On completion of the term the office bearer and members of the executive committee shall not be eligible to contest election or cooption in any representative capacity in the chamber for next one year. Provided that this rules shall not apply to the office bearer and members of the executive committee elected under the repealed Ordinance.



- (17) The election shall be held by secret ballot, and its official results shall be announced at the Annual General Meeting of the Chamber.
- (18) i The President of the Chamber shall be deemed to have automatically retired from his office on completion of his annual term of office.
If one out of 2 years of his tenure as Executive Committee member is still remaining he shall have all the privileges of member of Executive Committee including voting right.
- ii A Member of Executive Committee shall be eligible to be elected as President for "One year term" only twice, in his life time, provided that the gap between the two terms is at least one year.

Note:- In the event of reconstitution of the Executive Committee dissolved due to commitment of illegalities etc. the previous members of the dissolved Executive Committee, if any, when re-elected shall be entitled only to avail the remaining period of their tenure as admissible under these Articles.

QUORUM FOR EXECUTIVE COMMITTEE MEETING

ARTICLE 25

One third members of the Executive Committee shall form a quorum for transaction of business.

PRESIDING OVER MEETINGS

ARTICLE 26

The President or in his absence the Senior Vice President or in the absence of both of them, the Vice President shall preside over all the meetings, if neither the President nor the Senior Vice President nor the Vice President is present at the time the meeting is held, the members present shall choose someone from among themselves to preside over such meetings.

MANAGEMENT OF THE FUNDS AND ASSETS OF THE CHAMBER AND GENERAL POWERS OF THE EXECUTIVE COMMITTEE

ARTICLE 27

The management of the funds and assets of the Chamber shall be vested in the Executive Committee. The Executive Committee may in addition to the powers by these Articles expressly conferred upon them exercise all such powers and do all such acts and things as may exercised and done by the Chamber and are not hereby or under any bylaws expressly directed or required to be exercised or done by the Chamber in the General Meeting.
